Opening Plenary: “Student Ready” Colleges: A Look at Effective Institutions

••• **Dr. Belle S. Wheelan (SACSCOC)**

“Students Are Central to Success” is a phrase Dr. Belle Wheelan coined when asked about the acronym, SACS. It is common for colleges and universities to expect students to be ‘college-ready.’ However, it is less common for colleges and universities to ask themselves whether they are ‘student-ready.’ How do institutions measure whether they are effective at serving students? For nearly two decades, Dr. Belle S. Wheelan, a nationally renowned higher education leader, has been encouraging campus leaders to ‘believe their own data’ and take ‘courageous’ action in a timely manner. In this session, Dr. Wheelan reflects on the vicissitudes of the larger higher education accreditation work and offers ‘rules for the road’ for small colleges, and particularly HBCUs.

The speaker, Dr. Alice Lee Williams-Brown, is the author of “Cautionary Tales: Strategy Lessons from Struggling Colleges” and “How Boards Lead Small Colleges.”

When framed as 40% of the previous year’s revenue, the fiscal implications become clearer. This session frames retention as a fiscal strategy and offers insights on improving retention from two leaders in the throes of the work.

About 25 HBCUs were recipients of unrestricted and unsolicited gifts from MacKenzie Scott in the last three years – totaling over \$560 million. And there have been recent sizeable ‘investments’ to minority serving institutions and organizations to ensure that operations focused on social mobility continue. For institutions receiving windfalls and for those who have not felt a financial ‘windfall’ in years, there are still investment strategies to consider to improve financial strength. An expert in wealth management shares insights on how institutions might think strategically today about all investments to ensure a return on those investments.
